# 1. Opening and Welcome

Chair Annalisa Bisson opened the session by warmly welcoming all participants to the ENSA General Assembly 2025, both in-person and online. She acknowledged the international presence and thanked participants for their ongoing engagement with the network.

She highlighted the successful conclusion of the **HOPE Erasmus+ Project Conference** titled "Cooling the Heat: Responding to Heatwaves in the Older People Ecosystem" held the previous day, led by the City of Rotterdam. The event emphasized inclusive strategies to mitigate the impact of heatwaves on older adults, with the presence of high-level stakeholders including representatives from the European Commission and the Committee of the Regions.

The Chair provided an outline of the agenda and scheduled activities for the General Assembly, taking place on October 4 and 5, 2025. The programme includes:

#### **Topic** (ITALY ISRAA):

**Title VIOLET Story** addressing the pervasive issue of workplace violence in the healthcare sector though the use of DTS to raise awareness of the pervasive problem of workplace violence and to create a safer and more supportive work environment and to prevent abusive behaviour toward workers in the social and health sector.

**Title** Helping Empower and Assist Resilient Informal Carers Through Death Education: creating a local network of professionals capable of mobilizing resources, people, and public services to structure group pathways that empower individuals, offering them an "expressive-emotional psychological space" in which they can regenerate their resilience.

**Title** *Bridging Paradigms:* Improving digital literacy among older adults, bridging the generational digital divide while promoting psychological well-being through tailored training programs. The approach fosters social inclusion and lifelong learning, ensuring older adults remain connected and active.

**Title** Changing lifestyle and habits for better wellbeing in third age: empowering care and support of older people and informal caregivers in community, by intervening into qualitative characteristics of their lifestyle, as it is constructing positives and deconstructing negative habits and routines.

**Topic:** (Odisee University of Applied Sciences, Belgium)

**Title** Caring About Stress and Sleep in young onset dementia families: Stress management and sleep quality in partners and children of people with young onset dementia.

**Title** Learning communities for foster parents: working together for the wellbeing of unaccompanied minors: Establish and strengthen collaborative learning communities involving foster parents, professionals, and migrant youths to create networks of support and mutual learning.

**Decision 6:** The General Assembly took note of ENSA's involvement as an associated partner in various project proposals submitted under the Erasmus+, CERV, and other European programmes during the period 2024–2025. The Assembly acknowledges the strategic relevance of these collaborations in advancing ENSA's mission and endorses continued participation in such initiatives, subject to compliance with the network's objectives and applicable funding conditions.
