Who we are

The Rotterdam University of Applied Sciences: The School of Health Care Studies of Rotterdam University of Applied Sciences (RUAS) offers bachelor and master degree studies in the health care domain. Programs are being offered in powerful and flexible learning environments in which current developments and the work field are also leading elements. In addition, our school cooperates with the Research Centre Innovations in Care in systematic practice-based research within the work field, meant to improve the quality of both health care and education. The School of Health Care Studies is aware of the social importance of our mission and want to cooperate with all kinds of relevant partners to realize this. Among the strategic partners of the School of Health Care Studies are hospitals, health care centers and organizations for elderly care, rehabilitation, youth care and psychiatric care and psychiatric care as well as practices for physiotherapy, speech and language therapy, midwifery and occupational therapy. Within RUAS, the School of Health Care Studies works closely together with the bachelor programs Health technology and Social work.

ENSA: The ENSA European Network for Social Authorities is a network of cities and European regions that aims to promote international co-operation in the field of social care. Established by the Veneto region in 1999, the network has developed and supported strong partnerships between a wide range of regions and has carried out seminars, conferences, programs and numerous exchanges of practitioners. This co-operation includes several projects financed by the European Commission. The network organizes its work across five main areas – covering the elderly chair: City of Rotterdam; disability (Conseil Departmental du Val de Marne); children Flemish Agency for child welfare, youth and family chair Veneto Region. Once a year, working with the European institutions, a general assembly is held in order to share the lessons of the work done at local level and to participate actively in European policy-making and programs.

Youth Care Platform: The Youth Care Platform gathers national, regional and local authorities with legal responsibilities for the youth care sector and youth care providers and their umbrella organizations in EU Member States. Christine Gaschler-Andreasch, Head of Youth Welfare in Carinthia is chairing the platform.

ELISAN: Elisan, the European Local Inclusion and Social Action Network is a network of elected representatives set up with the support of the Committee of the Regions, with participatory status at the Council of Europe. This body promotes awareness of social actions at local level and seeks answers to social needs and rights issues.

Conference of INGO's of the Council of Europe, Committee on "Environmental and Health Crisis Governance and solidarity challenges": The cause and the dazzling worldwide spread of SARS-Cov-2 have increased States' awareness on the fragile complexity of ecosystems that shape the world, both its human settlements and all life forms. There is a need, more than ever, for a holistic approach and the urgency for a research focused on integral ecology, both environmental and human. In this framework, the committee's objective is to assist in identifying the components for an efficient and humane "recovery" (Build back better) but also in building a better future for the next generations (Building forward better), based on a real practice of democracy, at all levels of governance, through ethical, collaborative and participatory approach in the following areas: Environment and health, solidarity and resilience in the face of risks, good governance of metropolises and their hinterland to preserve and promote stability, peace and fraternity.

Inclusive cities for sustainable families: The project Inclusive Cities for Sustainable Families is a world alliance of Regions and territories promoted jointly by the International Federation for Family Development and the Veneto Region in collaboration with the ELISAN *European Local Inclusion and Social Action Network* and coordinated academically by the Universidad Nove de Julho UNINOVE (Brazil). This initiative aims to respond to the needs of families in these ten aspects, drawn up on the basis of the 2030 Agenda for Sustainable development: housing, New technologies, Education, Health, Safety, clean air, Transports, Accessibility, Leisure and Tourism and Vulnerable families. The commitment is to present, according to the Venice Declaration, once a year, in observance of the World Cities Day, the results achieved in these fields in particular for the implementation of SDG 11 that is making cities and human settlements inclusive safe resilient and sustainable.
